


OUR IMPACT

In the past year Family Service Association touched the lives of over 13,000 individuals across the Inland Empire region by providing a range of quality services and compassionate care. Our team worked tirelessly to support the recovery and rebuilding of our communities who are heavily impacted by the COVID-19 pandemic. Some of our highlights included:

- A total of 1,204 young children were educated, nurtured and cared for at FSA's 10 Child Development Centers.
- Nearly 3,170 community members were helped through a range of services at FSA's community and senior centers.
- A total of 8,647 seniors were provided nutritious home-delivered and curbside meals throughout 27 sites in the Inland Empire. Nearly one million meals were served to help keep seniors healthy, energized, and cared for.
- Over 200 individuals received high-quality counseling, therapy, and case management support through our clinical services department.
- Over 10,000 PPE supplies were distributed throughout the region to keep community members protected from COVID-19.

SERVING OUR REGION THROUGH INNOVATION AND PARTNERSHIP

Family Service Association is known for developing innovative programs and forging cross-sector collaboration to meet our community's most pressing needs. In August 2020, FSA partnered with the Southern California Gas Company (SoCalGas) to provide much-needed relief to thousands of seniors and dozens of small businesses throughout the Inland Empire.

Through the "Fueling Our Community" campaign, FSA provided more than 40,000 meals to seniors in 24 cities in the Inland Empire – many of which were located in rural and underserved areas. In addition to preparing meals from our in-house kitchens, FSA also distributed \$25.00 gift certificates from local restaurants which allowed participants to visit their favorite food spots and contribute to the local economy. The COVID-19 pandemic led to months of lost revenue and shortages in cash flow for small businesses throughout our region. Through this innovative partnership with SoCalGas, almost \$100,000 was infused into the economy, mostly through local eateries and restaurants that had been hit hard from the pandemic. After months of strain, gift certificates offered an immediate sense of security to restaurant owners and supported the reopening of their businesses.

DELIVERING LIFECHANGING SERVICES

Throughout the pandemic, Family Service Association (FSA) remained committed to offering its core clinical services that provide professional support and care across the region. These services have always been vital for community members, but with the pandemic, it became even more critical that individuals and families had access to therapeutic services. As society became largely virtual, many community members experienced isolation, stress, and anxiety. FSA's Clinical Department provided weekly parenting classes and one-on-one sessions during the pandemic that helped support new parents and parents with young children who were struggling to adjust to the changing situation. Our team of clinical therapists and case managers were able to teach families and help them navigate the daily challenges that arose from working, learning, and schooling at home.

CHILD ABUSE PREVENTION AND TREATMENT

The protection of children is everyone's responsibility. Since 2013, FSA has convened Riverside County's Child Abuse Prevention Council (CAPC), known as the HOPE Collaborative, to work towards the shared vision of a safe and secure environment for all children. COVID-19 presented many challenges for families including loss of employment, school closures, lack of healthcare, and many other familial stressors. To mitigate these stressors that can lead to child maltreatment, our team coordinated ongoing food and resource events throughout high-need communities in Riverside County. Families were supported with information and services on mental health, physical health, parenting classes, internet safety, and much more.



FORGING STRONG FAMILIES

At a basic level, if our communities don't have access to quality childcare services, then it becomes nearly impossible for families to reach financial security and foster strong, healthy relationships. Family Service Association is committed to providing quality childcare that offer relief. FSA's Child Development Centers educated and nurtured 1,204 young children last year – during a time in which our region's essential workers relied on childcare to serve our communities.

The COVID-19 crisis revealed what we have already known: Childcare services are essential for parents, employers, and the broader public and economy. Our region's frontline workers did not have the privilege of working from home and many families do not have the option of paying high-costs for childcare services. Throughout the pandemic, Family Service Association welcomed the children of essential workers and families by providing reliable, and safe care in an engaging environment.

The core of FSA's mission and services have always reflected a philosophy of care and compassion. But over the past year, we took this to the next level by integrating a trauma informed framework into our programs and services. Our entire workforce of over 300 team members were trained in understanding trauma, adverse experiences, the physiological consequences and physical ailments associated with trauma, and the power that a shift in perspective can bring towards healing. As FSA continues to make strides in becoming trauma-informed, we are confident that these efforts will inspire and nurture a community-wide transformation.



Total Revenue: \$25,347,741 Total Expense: \$22,719,371


REVENUE BY SOURCE
